Minutes of the last meeting accepted by Ken Jones, seconded by Andy Wagstaff.

### **2. Matters Arising**

Have contacted Môn CF who have accepted the contracts for the playing field and the new cemetery. But, Y Berth responded to ensure that we knew that their quotation was per cut, which would double the total. Stated that it was not possible for us to pay that sum, and so the work has gone to the next contractor, Mark Evans, who has accepted the work of cutting the footpaths.

### **3. Planning**

**21C170B** Change of use, an outbuilding to a dwelling. Bryn Celli Ddu, Llanddaniel. No objection.

### **4. Letters to Discuss**

- **Boundary Commission for Wales** A review of parliamentary constituencies in Wales. A second period of consultation open until 27 March. Re-iterate the opinion given before.
- **Anglesey Young Farmers** An opportunity to buy a brick in Builth Wells to raise money, £25, or other options.
- **Anonymous** A letter complaining about cutting trees in Bodfryn. Private property. Not a matter for the Community Council.
- **Cyngor Sir Ynys Môn** Temporary footpath closure.
- **Lisa Kelly-Roberts** A letter complaining about the road between Llanddaniel and Gaerwen. Speeding problem. This has also gone to the County Council. Also, a problem with dog mess and people having to walk along the road instead of along the pavement so a potential health and safety hazard. Note that the Council has a new policy to deal with dog mess and the people responsible and that should have an effect. And contact Wendy Kay regarding the speeding and enquire about the van which hasn't been seen for a while.

## 5. Constitution

Had thought that we did not need to have a Constitution, but several Community Councils have a such a document and it would have been useful in the past, and it will be generally useful.

A draft document has now been drawn up. Brings all of the rules together, in the form of a handbook. Suggest sending it around over email, and ask for comments, then respond to the clerk about this.

## 6. Adjudication Panel for Wales Decisions

An email has been sent around regarding the Adjudication Panel for Wales. Councillors being told off for misadventure. This has been read by everybody before the meeting.

## 7. Reports from any meetings

Playground sub-committee. An application was put in for the playground, and have heard today that we have been successful. Going to put a basket swing in the playground. Have held a community consultation. The most popular equipment is the swings, and people did not want to change the existing swings for a basket swing, but wanted more swings. Need to ensure that the mats under the existing swings are firmly fixed under the new flooring. Have had £3000 towards the swing and installation, but need to redo the mats. Looking at the most appropriate and cost effective options for the floors underneath the swings. Everybody has worked together really well.

Need to send an invoice to the Council as soon as possible.

The chairman wished to thank the team and praised their work.

Is there an application going in for the Shell money? Discussed this in the meeting and decided to leave this for the Trigolion to make the application this year, and make the application in the future.

## 8. County Councillor's Report

Two things have happened in the Executive Committee today. A private company to deal with waste and dog mess. Decided officially to employ the company. Very effective. HEJ has been worried for a while about staff illness, and the heads of departments have dealt with this and have been successful. 10 days on average, which is a reduction. Some departments worse than others.

Thanks to SER for writing an excellent letter regarding Parc Eurach. He attended the last meeting. A meeting at the beginning of the month to discuss the application again.

A long meeting, and the application was rejected by 4 votes to 3. But because they have gone against the recommendations of the officers, this needs to go to a second meeting. Difficult to say how this will go. A very difficult situation.

Should we write again? Not really. But send the letter again and insist that the letter is read out this time.

## **10. Any Other Business**

CD – Cylch Meithrin being set up in the school. The first meeting happens on Friday. A committee being established. 10 hours a week, free for 3 year olds, and wrap around care. To ensure the future of the school and to help parents.

SN – the work in extending the school. The trees by the playground are being removed and the willow tunnel will also go. The playground has had a drainage problem for a while, so this needs to be raised to ensure that proper drainage is ensured. A letter to the County Council stating this. And also request that the willow tunnel is relocated rather than taken out.

Dog mess problem. Someone is allowing their dog to make a mess in the playground. Ask the Council for a sign to prevent dogs. EJ – wait until the company has started work and pass the matter on to them, and note that the playground is a problem.

SG – need to send a leaflet around so that everybody knows about this and then they won't be able to complain if they already know the rules.

BF – poster competition. Have researched the best way of making the signs. Pay for making 10 – 5 by each winner. To put them on the way to the school, on the path to Gaerwen, around the playground. Powerful, educate the children. Need £120-£150 to pay for these.

DR – the small path from the bus stop to the shop has become very slippery. The Council is responsible for footpaths. Send a note to Highways.

SG – Brian has sourced a notice board. To be put up by the Trigolion sign. £389 + VAT.

Have heard from several people about the road which gets narrow, by Ken's house. People are having problems with cars coming up quickly, when they stop. Need to ask the Council for a sign to give priority to one of the lanes.
